Proposed Extension of Approval of Information Collection; Comment Request—Testing and Recordkeeping Requirements Under the Standard for the Flammability (Open Flame) of Mattresses

AGENCY: Consumer Product Safety Commission.

ACTION: Notice.

SUMMARY: As required by the Paperwork Reduction Act of 1995 (44 U.S.C. chapter 35), the Consumer Product Safety Commission (CPSC or 84 Commission) requests comments on a proposed 3-year extension of approval 73 of information collection requirements in the Standard for the Flammability-01 Open Flame-of Mattresses Sets (Open-64 Flame standard), 16 CFR part 1633. The Commission has a separate flammability 28 standard that addresses cigarette 89 ignition of mattresses, 16 CFR part 1632. 58 The Open-Flame standard is intended to 58 reduce unreasonable risks of burn 73 injuries and deaths from fires associated with mattresses, particularly those 70 initially ignited by open-flame sources, 58 such as lighters, candles, and matches. The Open-Flame standard prescribes a 28 test to minimize or delay flashover 22 35 when a mattress is ignited. The standard requires manufacturers to test 69 specimens of each of their mattress prototypes before mattresses based on 64 that prototype may be introduced into 39 commerce. The Office of Management

and Budget (OMB) previously approved the collection of information under control number 3041–0133. OMB's most recent extension of approval will expire on March 31, 2013. The Commission will consider all comments received in response to this notice before requesting an extension of approval of this collection of information from OMB.
