

to the Temporary Restrictions list for the import of animal commodities imported from or transiting Costa Rica. Subsequent follow-up reports to WOA, as well as epidemiological reports submitted to APHIS from Costa Rica's National Service for Animal Health, indicated further detections of screwworm in livestock, including cattle and sheep. Therefore, on August 21, 2023, APHIS added Costa Rica to the list of regions APHIS considers affected with screwworm.

As a result, horses, ruminants, swine, and dogs from Panama and Costa Rica are subject to APHIS import restrictions designed to mitigate risk of screwworm introduction into the United States. This notice serves as an official record and public notification of these actions.
