Take notice that on February 28, 2025, East Cheyenne Gas Storage, LLC (East Cheyenne), 370 Van Gordon Street, Lakewood, Colorado 80228, filed an application under sections 7(b) and 7(c) of the Natural Gas Act (NGA) and part 157 of the Commission's regulations

requesting authorization to abandon the certificated natural gas storage capacity of the West Peetz and Lewis Creek oil and gas fields located in Logan County, Colorado and to amend the certificate of public convenience and necessity issued by the Commission in Docket No. CP10-34-000¹ (Project). The Project will involve: (1) reducing the certificated working gas capacity of the fields from 22.5 Bcf to 12.5 Bcf, (2) increasing the base gas capacity from 15.7 Bcf to 22.1 Bcf, and (3) reducing the maximum injection/withdrawal rate of the fields from 350 million cubic feet per day (MMcf/d) to 210 MMcf/d. The Project will allow East Cheyenne to reduce its certificated storage capacity to conform to the current physical conditions of its facilities installed by previous owners, all as more fully set forth in the application which is on file with the Commission and open for public inspection.
