HCUP Data Purchase Ordering Form. The total burden to complete these four steps to purchase HCUP data is estimated to be 1,050 hours annually. Exhibit 2 shows the estimated annualized cost burden associated with the applicants' time to purchase HCUP data. The total cost burden is estimated to be \$78,252 annually.
