#### United States Standards for Dry Whey

**AGENCY:** Agricultural Marketing Service, USDA.

**ACTION:** Notice.

**SUMMARY:** This document gives notice of the availability of revisions to the United States Standards for Dry Whey. The changes will: lower the bacterial estimate of not more than 50,000 per gram to not more than 30,000 per gram; incorporate maximum scorched particle content as a requirement for U.S. grade; expand the "Test Methods" section to allow product evaluation using the latest methods included in the Standard Methods for Examination of Dairy Products, in the Official Methods of Analysis of the Association of Official Analytical Chemists, and in standards developed by the International Dairy Federation; reference the Food and Drug Administration's requirements for dry whey; and make editorial changes that would provide consistency with other U.S. grade standards for dairy products.

**EFFECTIVE DATE:** This notice is effective December 14, 2000.

**SUPPLEMENTARY INFORMATION:** Section 203(c) of the Agricultural Marketing Act of 1946, as amended, directs and authorizes the Secretary of Agriculture "to develop and improve standards of quality, condition, quantity, grade, and

packaging and recommend and demonstrate such standards in order to encourage uniformity and consistency in commercial practices \* \* \*." AMS is committed to carrying out this authority in a manner that facilitates the marketing of agricultural commodities and will make copies of official standards available upon request. The United States Standards for Dry Whey no longer appear in the Code of Federal Regulations (CFR); however, they are maintained by USDA.

AMS is revising the United States Standards for Dry Whey using the procedures it published in the August 13, 1997, **Federal Register** and that appear in Parts 36 of Title 7 of the CFR.

The notice, which included a request for comments on the proposed changes, was published in the **Federal Register** on June 20, 2000 (65 FR 38235-38239), and a correction to the notice was published in the **Federal Register** on July 17, 2000 (65 FR 44024-44025).

The current United States Standards for Dry Whey have been in effect since October 1, 1990. AMS initiated a review of this standard and discussed possible changes with the dairy industry. The American Dairy Products Institute, a trade association representing the dry whey industry, provided specific suggestions, including a suggestion to lower the maximum bacterial content requirement. AMS proposed other changes to reflect improvements in the quality of dry whey that have occurred since the standards were last revised and to promote greater uniformity and consistency in the application of this standard.

AMS published the notice in the **Federal Register** with an outline of the specific proposed changes and provided a comment period of 60 days, which ended on August 21, 2000.

The American Dairy Products Institute filed a comment supporting the proposed changes. No other comments were received.

AMS discovered a typographical error in the ZIP code for the Association of Official Analytical Chemists. The ZIP code that appears in the "Test Methods" section of the revised standard should read 20877-2417. Accordingly, the notice revising the United States Standards for Dry Whey published in the **Federal Register** at 65 FR 38235-38239 on June 20, 2000, the notice of correction published in the **Federal**

**Register** at 65 FR 44024-44025 on July 17, 2000, and the correction to the ZIP code as made above are incorporated in the revised United States Standards for Dry Whey.

**AGENCY:** Agricultural Research Service, Agriculture.

**ACTION:** Notice of Meeting.

**SUMMARY:** In accordance with the Federal Advisory Committee Act, 5 U.S.C. App., the United States Department of Agriculture announces a meeting of the Advisory Committee on Agricultural Biotechnology (ACAB).

**SUPPLEMENTARY INFORMATION:** The third meeting of the ACAB has been scheduled for November 29-30, 2000. The topics to be discussed will include: (1) The USDA's public seed breeding program and plant germplasm repositories; (2) impacts of gene flow from transgenic crops to other plants and current and potential USDA roles in addressing them; and (3) biotechnology budget priorities for FY 2002. There will in addition be several updates on current biotechnology developments, including the Starlink® corn situation, and on ongoing USDA biotechnology-related activities.

Members of the public who wish to make oral statements should also inform Dr. Schechtman in writing or via E-mail at the indicated addresses at least three business days before the meeting. On

November 29, 2000, if time permits, reasonable provision will be made for oral presentations of no more than five minutes each in duration. Written statements may be submitted to the Committee before or after the meeting at the address indicated below.

**ACTION:** Notice and Request for Comments.

**SUMMARY:** In accordance with the Paperwork Reduction Act of 1995, this notice announces the intent of the Farm Service Agency (FSA) to request an extension of a currently approved information collection for a regulation used in support of the FSA Farm Loan Program (FLP). This renewal does not involve any revisions to the program rules.

*Type of Request:* Extension of Currently Approved Information Collection.

*Abstract:* The regulations describe the policies and procedures the Agency will use in servicing delinquent FLP loans. Servicing of accounts is administered in accordance with the provisions of the Consolidated Farm and Rural Development Act (CONACT), as amended by the Food Security Act of 1985, the Agriculture Credit Act of 1987, the Food, Agriculture, Conservation and Trade Act of 1990, the Agricultural Credit Improvement Act of 1992, and the Federal Agriculture Improvement and Reform Act of 1996. The CONACT establishes notification by the Agency and response by the borrower and actions on the borrower's request. Specifically, it requires a borrower to document that they can meet family living and farm operating expenses and service all debts, including the loans they are proposing be restructured by the Agency. This information collection is submitted by Agency borrowers to FSA and used by Agency officials to consider a financially distressed or delinquent borrower's request for debt restructuring including rescheduling, reamortization, consolidation, deferral, and write down.

*Estimate of Burden:* Public reporting burden for this collection of information is estimated to average 47 minutes per response.

*Respondents:* Individuals or households, businesses or other for profits and farms.

*Estimated Number of Respondents:* 12,000.

*Estimated Number of Responses per Respondent:* 1.73.

*Estimated Total Annual Burden on Respondents:* 16,000 hours.

The Agency is soliciting comments on the burden of all of the above subparts regarding: (a) Whether the collection of information is necessary for the proper performance of the functions of the

agency, including whether the information will have practical utility; (b) the accuracy of the agency's estimate of burden including the validity of the methodology and assumptions used; (c) ways to enhance the quality, utility and clarity of the information to be collected; (d) ways to minimize the burden of the collection of information on those who are to respond, including through the use of appropriate automated, electronic, mechanical, or other technological collection techniques or other forms of information technology.
