I. Background

Pursuant to the Privacy Act of 1974,
5 U.S.C. 552a, FDIC is establishing a
new system of records, FDIC-039, E-
Rulemaking System of Records. FDIC
collects comments on rulemakings and
other regulatory actions, which it
publishes on its website to provide
transparency in the informal rulemaking
process under the Administrative
Procedure Act (APA), 5 U.S.C. 553, and
in the regulatory processes established
by the Federal Deposit Insurance Act, 12
U.S.C. 1811. FDIC also may solicit
comments or other input from the
public that may not be associated with
statutory or regulatory notice and
comment requirements.

The E-Rulemaking system collects
and stores comments and input received
by the Corporation. Specifically, the
system includes an option on [https://
www.fdic.gov/resources/regulations/
federal-register-publications/](https://www.fdic.gov/resources/regulations/federal-register-publications/) that
allows individuals to electronically
submit their comments or input to FDIC.
The system collects the email address of
the commenter, along with any
additional information that the
commenter elects to include in their
submission, such as their name,
organization, and contact information.
Once submitted, the system stores this
information in the E-Rulemaking
database. Any comments received by
fax, postal mail, or email are uploaded
by authorized FDIC personnel into this
database, collecting all comments into
one central repository. The commenter's
email address, name, organization, work
contact information, and comment are
published to [https://www.fdic.gov/
resources/regulations/federal-register-
publications/](https://www.fdic.gov/resources/regulations/federal-register-publications/). The commenter's
personal contact information, or other
additional personal information
voluntarily submitted, is generally not
published online. The FDIC may review,
redact, or refrain from posting all or any
