**Determination of Overfishing or an Overfished Condition**

**AGENCY:** National Marine Fisheries Service (NMFS), National Oceanic and Atmospheric Administration (NOAA), Commerce.

**ACTION:** Notice.

**SUMMARY:** This action serves as a notice that NMFS, on behalf of the Secretary of Commerce (Secretary), has found that witch flounder and Saint Matthew Island blue king crab continue to be overfished; Gulf of America lane snapper, Southern Atlantic snowy grouper and Southern Atlantic gag continue to be subject to overfishing; and Southern Atlantic blueline tilefish is now subject to overfishing. NMFS, on behalf of the Secretary, is required to provide this notice whenever it determines that a stock or stock complex is subject to overfishing, overfished, or approaching an overfished condition.

**SUPPLEMENTARY INFORMATION:** Pursuant to section 304(e)(2) of the Magnuson-Stevens Fishery Conservation and Management Act, 16 U.S.C. 1854(e)(2), NMFS, on behalf of the Secretary, must

notify councils, and publish a notice in the **Federal Register**, whenever it determines that a stock or stock complex is subject to overfishing, overfished, or approaching an overfished condition. To comply with Executive Order (E.O.) 14172, this notice uses the term “Gulf of America” for all references to the area referred to as the “Gulf of Mexico” in the regulations at 50 CFR part 622.

NMFS has determined that Northwestern Atlantic witch flounder continues to be overfished. This determination is based on the most recent assessment completed in 2024 and using data through 2023 that continued to support the determination that the stock remains overfished. NMFS continues to work with the New England Fishery Management Council to rebuild this stock.

NMFS has determined that the Saint Matthew Island blue king crab continues to be overfished. This determination is based on the most recent assessment, completed in 2024 using data through 2024 that found that the mature male biomass is less than the minimum stock size threshold. NMFS continues to work with the North Pacific Fishery Management Council to rebuild this stock.

NMFS has determined that Gulf of America lane snapper continues to be subject to overfishing. This determination is based on landings data from 2023 that found the landings were greater than the overfishing limit (OFL). NMFS continues to work with the Gulf of Mexico<sup>1</sup> Fishery Management Council to end overfishing on this stock.

NMFS has determined that both Southern Atlantic snowy grouper and Southern Atlantic gag continue to be subject to overfishing. These determinations are based on landings data from 2023 that found the landings were greater than the OFL for both stocks. NMFS continues to work with the South Atlantic Fishery Management Council to end overfishing on these stocks.

NMFS has determined that Southern Atlantic blueline tilefish is now subject to overfishing. This determination is based on landings data from 2023 that found the landings were greater than the OFL. NMFS has notified the South Atlantic Fishery Management Council of its requirement to end overfishing.

The Department of Commerce will submit the following information collection request to the Office of Management and Budget (OMB) for review and clearance in accordance with the Paperwork Reduction Act of 1995, on or after the date of publication of this notice. We invite the general public and other Federal agencies to comment on proposed and continuing information collections, which helps us assess the impact of our information collection requirements and minimize the public's reporting burden. Public comments were previously requested via the **Federal Register** on December 17, 2024, during a 60-day comment period. This notice allows for an additional 30 days for public comments.

**Agency:** National Oceanic and Atmospheric Administration (NOAA), Commerce.

**Title:** Coastal and Estuarine Land Conservation Planning, Protection or Restoration.

**Type of Request:** Regular submission (extension of a current information collection).

**Number of Respondents:** 55.

**Average Hours per Response:** Coastal and Estuarine Land Conservation Planning (CELCP) Plans, 120 hours to develop, 35 hours to revise or update; project application and checklist, 20 hours; final grant application for selected projects, 3.5 hours; semi-annual and annual reporting, 1.5 hours each.

**Total Annual Burden Hours:** 1,455.

**Needs and Uses:** This request is for extension of a currently approved information collection. NOAA has, or is given, authority under the Coastal Zone Management Act (CZMA), annual appropriations or other authorities, to issue funds to coastal states, localities, or other recipients for planning,

conservation, acquisition, protection, restoration, or construction projects. The required information enables NOAA to implement the Coastal and Estuarine Land Conservation Program (CZMA Section 307A), under its current or future authorization, and facilitate the review of similar projects under different, but related, authorities, including the National Estuarine Research Reserve System (CZMA Section 315) Land Acquisition and Construction program; the Coastal Zone Management Program's low-cost acquisition and construction program (CZMA Section 306A), or the Fish and Wildlife Coordination Act.

**Affected Public:** Primary respondents are State, Local, or Tribal government.

**Frequency:** Information is collected once every five years for CELCP plans; one time each year for project proposals, final grant applications, and due diligence materials for selected projects; two times per year for progress reports.

**Respondent's Obligation:** Required to Obtain or Retain Benefits.

**Legal Authority:** Coastal Zone Management Act (16 U.S.C. 1451 *et seq.*)

#### Notice of Intent To Prepare a Supplemental Environmental Impact Statement for the Expansion of the Foreign Military Sales F–35 Pilot Training Center at Ebbing Air National Guard Base, Arkansas

**AGENCY:** Department of the Air Force, Department of Defense,

**ACTION:** Notice of intent.

**SUMMARY:** The Department of the Air Force (DAF) is issuing this Notice of Intent (NOI), in accordance with the National Environmental Policy Act (NEPA), to prepare a supplemental environmental impact statement (SEIS) to evaluate the potential environmental impacts associated with proposed changes to the Foreign Military Sales (FMS) Pilot Training Center (PTC) at Ebbing Air National Guard (ANG) Base where the ANG is a tenant at Fort Smith Regional Airport, Arkansas. The SEIS evaluates the Proposed Action, the Refine Operations Alternative, and the No Action Alternative. The DAF is the leading agency on the preparation of this SEIS and the Federal Aviation Administration (FAA), the Airports Division, is participating as a cooperating agency because the action involves changes to the Airport Layout Plan.

**SUPPLEMENTARY INFORMATION:** In January 2023, the DAF published the *Beddown of a Foreign Military Sales (FMS) Pilot Training Center (PTC) at Ebbing Air National Guard Base, Arkansas or Selfridge Air National Guard Base, Michigan Final Environmental Impact Statement* (hereinafter referred to as the "2023 FMS PTC EIS") and signed the DAF Record of Decision (ROD) on March 11, 2023, selecting Ebbing ANG Base as the location to establish the FMS F–35 PTC. The FAA also served as a cooperating agency for the development of the initial EIS. After the signing of the DAF ROD for the 2023 FMS PTC EIS, new training requirements have emerged due to additional FMS purchases of F–35 aircraft, including operations that incorporate the F–35B's Short Takeoff and Vertical Landing (STOVL) capabilities.

The purpose for the DAF's Proposed Action furthers the 2023 FMS PTC EIS and ROD to establish a permanent FMS
