Following this scoping period, Commission staff will determine whether to prepare an Environmental Assessment (EA) or an Environmental Impact Statement (EIS). The EA or the EIS will present Commission staff's independent analysis of the issues. If Commission staff prepares an EA, a "Notice of Schedule for the Preparation of an Environmental Assessment" will be issued. The EA may be issued for an allotted public comment period. The Commission would consider timely comments on the EA before making its decision regarding the proposed project. If Commission staff prepares an EIS, a "Notice of Intent to Prepare an EIS/ Notice of Schedule'' will be issued, which will open up an additional comment period. Staff will then prepare a draft EIS which will be issued for public comment. Commission staff will consider all timely comments received during the comment period on the draft EIS and revise the document, as necessary, before issuing a final EIS. Any EA or draft and final EIS will be available in electronic format in the public record through eLibrary <sup>3</sup> and the Commission's natural gas environmental documents web page (https://www.ferc.gov/industries-data/ natural-gas/environment/ environmental-documents). If eSubscribed, you will receive instant email notification when the environmental document is issued.

With this notice, the Commission is asking agencies with jurisdiction by law and/or special expertise with respect to the environmental issues of this project to formally cooperate in the preparation of the environmental document.<sup>4</sup> Agencies that would like to request cooperating agency status should follow the instructions for filing comments provided under the Public Participation section of this notice.

# Consultation Under Section 106 of the National Historic Preservation Act

In accordance with the Advisory Council on Historic Preservation's implementing regulations for section 106 of the National Historic Preservation Act, the Commission is using this notice to initiate consultation with the applicable State Historic Preservation Office, and to solicit their views and those of other government agencies, interested Indian tribes, and the public on the project's potential effects on historic properties.<sup>5</sup> The environmental document for this project will document findings on the impacts on historic properties and summarize the status of consultations under section 106.

## Golden Triangle Storage, LLC; Notice of Application and Establishing Intervention Deadline

Take notice that on March 31, 2025, Golden Triangle Storage, LLC (GTS), 919 Milam Street, Suite 2425, Houston, Texas 77002, filed an application under section 7(c) of the Natural Gas Act (NGA) and Part 157 of the Commission's regulations requesting authorization for its Spindletop Expansion Project (Project) at its existing Central Storage Site in Jefferson County, Texas. The Project consists of: (1) four new salt dome storage caverns and well pads, (2) ten 5,500 horsepower gas-fired reciprocating engine compressor units, and (3) various appurtenances. The Project will add 30.75 billion cubic feet (Bcf) of working gas capacity and 24.2 Bcf of base gas capacity. The aggregate injection and withdrawal capability at the Central Storage Site will increase by 1,000 million cubic feet per day. Additionally, GTS requests reaffirmation of its existing marketbased rate authority, all as more fully set forth in the application which is on file with the Commission and open for public inspection.

If a Notice of Schedule for Environmental Review is issued, it will indicate, among other milestones, the anticipated date for the Commission staff's issuance of the final environmental impact statement (FEIS) or environmental assessment (EA) for this proposal. The filing of an EA in the Commission's public record for this proceeding or the issuance of a Notice of Schedule for Environmental Review will serve to notify federal and state agencies of the timing for the completion of all necessary reviews, and the subsequent need to complete all federal authorizations within 90 days of the date of issuance of the Commission staff's FEIS or EA.
